**5. Firefighting Measures**

**6. Accidental Release Measures**

**Containment** In all cases design storage to prevent discharge to stormwater.  
**Emergency procedures** In the event of a large spillage (>100kg) alert the fire brigade to location and give brief description of hazard.  
 Prevent by whatever means possible any spillage from entering drains, sewers, or water courses. (If this occurs contact your regional council immediately).  
**Clean-up method** Collect product avoiding any dust formation, and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

**Engineering Controls**

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. If during exposure to a concentrated aqueous solution/slurry, dust and mist is likely, a full face respirator with a particulate filter is recommended.
